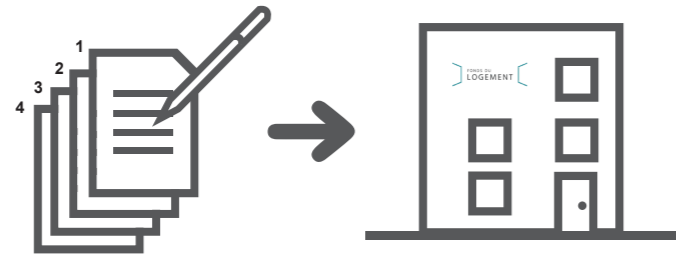


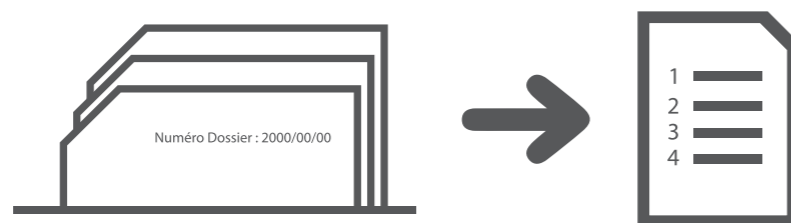


4 steps to obtaining subsidised rental housing

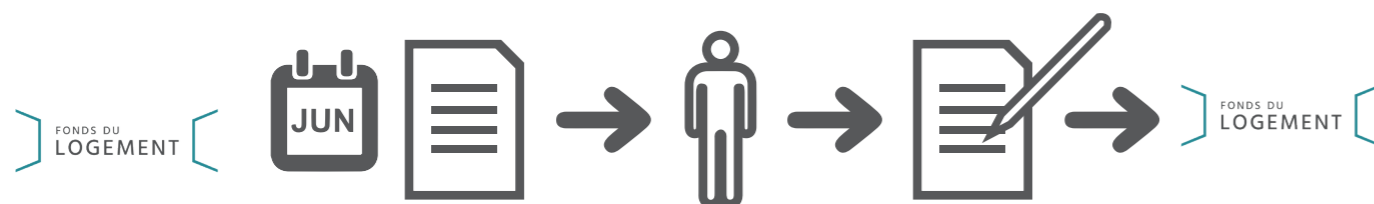
1. Presentation of all the required documents to the Fonds du Logement (Housing Fund)



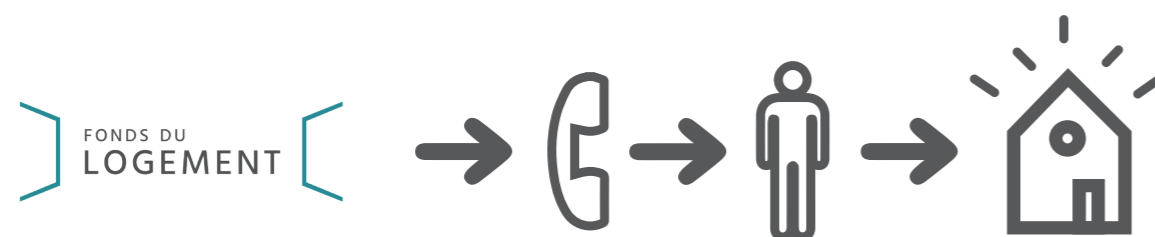
2. Allocation of a file number and registration on our waiting list for subsidised rental housing



3. Yearly request of confirmation and updating of your file in June



4. In case of vacancy of any accommodation, the applicant is contacted by the Fonds du Logement

2.2. Protection of your personal data

Pursuant to European Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, information relating to the processing of your personal data by the Fonds du Logement is contained in an information notice on the protection of your personal data, which we advise you to read carefully. This information notice is published on the website of the Fonds du Logement www.fondsdulogement.lu under "Protection des données personnelles". A copy of this notice may also be obtained in the premises of the Fonds du Logement, 52 Boulevard Marcel Cahen, L-1311 Luxembourg, or sent to you by post or e-mail upon request, by calling 262644-1 or sending an e-mail to the address: accueil@fondsdulogement.lu. To be able to process your personal data and examine your application for subsidised rental housing, the Fonds du Logement requires your prior:

- Consent for the specific processing of your personal data as well as data concerning the persons in your household, collected from the Registre National des Personnes Physiques (National Register of Natural Persons),
- Consent for the processing of personal data relating to your underage children (under 16),
- Consent for the processing of your personal health data (for applications for housing for persons with reduced mobility),

Important information :

- Only households which are not the owners, usufructuaries or leaseholders of a dwelling and which have no right of occupation in respect of another dwelling are eligible for subsidised housing.
- Incomplete applications will not be taken into consideration.
- Inaccurate or incomplete statements shall entail the archiving of the application.
- Any changes in your circumstances must be reported to the Fonds du Logement, as it may affect your status on the housing register.

- 2 Copy of the certificate of affiliation with CNS Social Security < 3 months for all adults in the household who are not attending school.

- 4 Proof of benefits dated within last 3 months :

- 7 Copy of current lease
- 8 Rent (proof of payment of rent, transfer, etc.)

HOUSING FOR PERSONS WITH REDUCED MOBILITY

- 9 Medical certificate assessing that the applicant needs adaptations or special requirements to his/her accommodation adapted to his/her disability. This certificate must be issued by a GP.

Medical certificate of the attending physician or disability certificate issued by the applicants health insurance fund.
